## PRIVACY DISCLOSURE

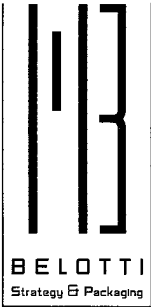
Dear Supplier,

the personal data provided are processed by Marino Belotti s.r.l. ("the Company") acting as controller, for the purposes linked to our business relationship, such as business communication related to cosmetic packaging and new items' presentation, through IT communication means (e-mail). This activity could also be carried out by third parties/entities, entrusted by our Company, for supplying this specific kind of service, always with reference to our business relationship and in full compliance with the legislative provisions on data protection and security.

The data retention period in our IT system is not specifically defined. The data will not be stored, used or given to third parties in case of termination of any business relationship between our Companies.

Moreover, please be informed that:

- 1) Your personal data processing is required for the performance of the existing contract between the parties. It is mandatory to provide the requested data for the above mentioned purposes, strictly linked to the execution of the pre-contractual and contractual relationship. Any refusal to provide the above mentioned data entails the inability to carry out the activities linked to the contract performance and conclusion;
- 2) The data will be used exclusively in our Company. The personal data will not be transferred to third parties. In case the transfer will happen, it will be performed in full compliance with the security measures taken by our Company and according to the current Security Policy;
- 3) Your personal data retention, with reference to the operational and contractual phase, will be stored for the whole duration of the business relationship between the parties;
- 4) You have always the right to withdraw your agreement at any time. The agreement withdrawal will not undermine the lawfulness of the data processing, based on the agreement before the withdrawal (art. 7 §.3 of EU Regulation 679/2016);
- 5) With reference to the data processing for the above mentioned purposes, you always have the right to ask our Company the access, amendment or cancellation of your personal data. You have also the right to ask for the data processing limitation or objection, as well as to exercise the right to data portability;
- 6) Any communication linked to the application of the above mentioned Eu Regulation 679/2016, with particular reference to the exercise of rights of the concerned entity at point 5, shall be executable by addressing the Controller, among Marino Belotti s.r.l. 7) You always have the right to lodge a complaint with the supervisory authority (art. 13, §. 2, letter d) of the EU Regulation 679/2016).

### **Processing of your personal data for business and advertising purposes**

Your personal data should be processed by the Company for marketing and/or advertising activities, related to Marino Belotti srl products and services.

To this end, we ask for your express consent, so that:

- a) your name, contact details and information provided (address, e-mail, phone number, instant messaging ID, social network address);
- b) information about the purchased products and used services (for instance consultancy / training contracts),

can be collected, processed and used. Data will be used for proposing customized offers and offers in line with your interests, through phone contact, e-mail or ordinary mail.

In order to allow this activity, data will also be used for analysis processes, including the creation of profiles for our interests assessment. The personal data processing activity for the above mentioned purposes is based on the legitimate interest of our Company and its consent. The disclosure of this consent is on a voluntary basis, until withdrawal of the consent itself or in case of objection to the processing you will be able to give at any time, through the addresses indicated on point 6. The withdrawal of your consent will not undermine the legality of the data processing activity or of any other legal processing activity, carried out based on the consent, until withdrawal. You will have the right to receive information about your personal data at any time, to ask for their modification or cancellation, to restrict the processing activity and to lodge a complaint both with our Company, and with a supervisor authority. Moreover, you will always have the possibility to exercise the right of data portability. Your personal data will be stored for the period of time necessary to pursue the above mentioned purposes. Moreover, you will have the right to object to your personal data processing activity for profiling purposes, in so far as it relates to direct marketing.
